

Meet LifeSource Chief Executive Officer **Q&A WITH KELLY WHITE**

What made you want to join LifeSource?

I truly believe so many moments big and small led me here. In the early years of my career as a bedside nurse, I supported patients who experienced life-ending injuries and went on to become organ donors. Later, I had the honor of supporting LifeSource with their first donor patient experiencing circulatory death.

Then in 2007 I lost my dad to ALS; he became an eye donor. I was on the other side of this work as a donor family member.

All those experiences prepared me to lead LifeSource. While serving in leadership roles at Hennepin Healthcare and North Memorial Health, I did some deep work around diversity, equity and inclusion. While I'm still a student focused on learning, I am relentlessly committed to the journey and feel it's both the right thing to do and imperative to our work around saving lives.

What are your reflections since you started with the organization?

I am in awe of the team at LifeSource. They are smart. They are talented. They are deeply committed.

What would we see you doing on a day off?

Cheering on my twins – my daughter is a competitive dancer, and my son is a swimmer. I also love to read and workout.

Anything else you'd like to add?

I cannot wait to meet each one of you in the coming year and I look forward to hearing your story of what connects you to this mission.

SAVING MORE LIVES

Organ Donation

Goal: Achieve 1,000 transplants from local donors in 2027 In 2022, LifeSource achieved 760 transplants from local donors (33% increase from 2021).

Donor Hospital Standouts Record Years

Mayo Clinic, the University of Minnesota, Sanford Medical Center in Fargo, Abbott Northwestern Hospital, CHI St. Alexius Health in Bismarck, Fairview Southdale, Avera McKennan Hospital & University Health Center, Monument Health Rapid City Hospital and St. Cloud Hospital all met or exceeded any previous milestones for organ and tissue donors cared for.

Double the Impact

St. Cloud Hospital collaborated with LifeSource to care for 19 organ donors and 57 tissue donors, nearly doubling any previous milestone year.

First-Time Donor Hospitals First ever organ donations occurred at Maple Grove Hospital and Grand Itasca Clinic and Hospital.

Honoring the Wishes of Covid+ Donors

Advances in science and medicine made it possible for us to honor the wishes of 31 patients who were also COVID positive at the time of their death; 69 organs were transplanted from those donors.

Tissue Donation

Goal: Recover gifts from 1,000 tissue donors in 2022.

On December 19, 2022, LifeSource raised the Donate Life Flag (pictured below) to honor a historic milestone: fulfilling the wishes of more than 1,000 tissue donors in a single year - a record since our tissue program began in 1999. The total tissue donors for 2022 was 1,058.

WAASIZO GICHIANONG NINGAABII'ANONG SHINING BIG STAR IN THE WEST



G reyson Lawrence Parisien was a sweet, silly little boy. His big sister, Parker, was so proud to show him off. Born with a congenital heart defect (Tetralogy of Fallot), Greyson's family learned that he would need surgery. Before he was even six months old, Greyson and his family made the nine-hour trip from the Turtle Mountain Reservation in Belcourt, North Dakota to the Mayo Clinic in Rochester, Minnesota.

Greyson underwent a 13-hour surgery to fix his little heart; but, a few days later, Greyson went into cardiac arrest. While doctors were able to stabilize him with CPR and life supporting measures, his heart could not recover from the event. Next, he was put on a Berlin Heart (external heart) that would keep him alive until he could receive a heart transplant.

For 12 months Greyson would remain in the hospital awaiting a heart with his parents, Reeanne and Ridge, by his side. Through all his hardships, Greyson kept his smile. He was a happy little guy who loved music and the sound of ripping paper. His happiness was infectious, and he brought a smile to all his doctors and nurses.

The Support of Family

During this time, Greyson's entire family did what they could to support him and each other. Greyson's sister Parker would visit every other week with Grandma (Joan) and Grandpa (Keith). Parker was only six years old, but she seemed to know how sick her brother was and prayed every day for him to get a new heart.

On Thanksgiving Joan broke the wishbone off the turkey and she and Parker made a wish on it. Parker couldn't keep her wish a secret and told Joan that she wished for a new heart for her brother.

A New Heart for Greyson

In April of 2019, Greyson received the gift he and his family had so patiently waited for – a new heart. The entire family was overjoyed that he would have a chance to live a healthy life. Parker was especially excited because her Thanksgiving wish had come true.

The Mayo Clinic staff provided the caring and loving support the family needed during this time and had become like family. They threw Greyson a huge going away party when he was discharged in spring 2019 – exactly one year after he was admitted. Greyson and his family remained in Rochester for a few months so he could be monitored for complications and rejection.

So when you check the box, remember the little boy with the black-rimmed glasses who smiled through every hardship," said Joan Azure to her fellow tribal members. "By doing this, we're honoring him."

Homecoming

Two months later, Greyson was officially on his way back home to the Turtle Mountains. A huge homecoming event welcomed the little hero home including a police escort, numerous speakers (a LifeSource team member spoke to the audience about organ donation), a meal and traditional music. Hundreds of community members were in attendance.

The next few months consisted of family time, doctors' appointments and getting reacquainted with the community he had left 14 months earlier.

Greyson Gets His Name

One day in September Greyson didn't seem to be feeling well. He had molars coming in and Reeanne thought he was simply teething. She brought him in to see the pediatric cardiologist for an echocardiogram just to make sure everything was okay. His tests looked fine, and the echo results looked great. A few days later his health deteriorated, and his family learned he had pneumonia. At just 21 months old, Greyson passed away from complications of the illness.

Shortly after his death, an elder in the community gave him his traditional name: *Waasizo Gichi Anong Ningaabii' Anong*, which translated means "Shining big star in the west."

It was a sad day in the community when little Greyson "went to be with the angels." Joan recalls driving through town early in the morning after the day of his passing. It felt like there was a dark cloud over the entire reservation and everyone was crying. Roads that were usually busy with traffic were empty and there was an overwhelming feeling of sadness.

Later that day as the drums played to help Greyson on his journey, the eagles appeared to help family and friends with their sadness and grief. The fire and drums went for three days and nights and could be heard from miles away – hundreds, maybe even thousands, of people paid their respect to this little boy, who brought love, laughter and unity to a community in his short time on earth.

Advocacy in Honor of Greyson

Right now, the primary way people register as an organ, eye and tissue donor is on a driver's license or state ID.

After seeing a heat map of registration rates across North Dakota – with the lowest rates corresponding with tribal lands – Joan Azure had the idea around adding the option to tribal identification documents. This could provide the opportunity for Turtle Mountain Band of Chippewa tribal members who don't have a state ID.

On June 7, 2022, the Tribal Council of Turtle Mountain adopted "The Greyson Initiative," a law to add organ, eye and tissue donor registration on tribal identification documents. The Turtle Mountain Band of Chippewa are the first to say "yes" to offering this option for their members.

Right now, the need for more organs, especially kidneys, is great. There are nearly 3,000 people across Minnesota and North and South Dakota waiting for a life-saving transplant. Of those, 142 identify as American Indian/Alaska Native, Non-Hispanic. There currently aren't enough organ donors to meet the need. All too often, our loved ones die waiting.

The need is great, yet only 19% of people from tribal communities or who identify as American Indian/Alaska Native say "yes" to donation when approached in the hospital compared to 60 percent of people who identify as white. While race and ethnicity aren't required to match for successful transplantation, it can help. And the bigger pool of donors we have, the more lives can be saved.

Greyson's Legacy

Greyson's family and community carry on his legacy in other ways. Joan and Reeanne advocate for organ donation and use Greyson's story to encourage more people to check the box. Greyson's grandfather Keith visits his grave daily – even when it's -30° in North Dakota – to pray with him and ask him to watch over everyone.

Events are held in Greyson's honor throughout the year.

Lumberjack Days Outreach Booth LifeSource staff and ambassadors were eager to be back out in the community at this first major outreach event since the pandemic began. Held in Stillwater, MN, this three-day event in July fostered hundreds of conversations about organ, eye and tissue donation. In 2021, Stillwater became the first "Donate Life City" in the country.



Transplant Games of America

In July, athletes from across Minnesota, North Dakota and South Dakota came together as "Team MN-DAK" to participate in the Transplant Games of America. This competition attracting recipient athletes worldwide, demonstrates what is possible thanks to the the generosity of organ donation. Team MN-DAK took home 60 medals in the 2022 Transplant Games.



Wellness Block Party Fosters **Trusted Relationships**

On Saturday, August 20, LifeSource team members gathered with fellow members of the North Minneapolis community members for this inaugural "Live Your Healthy Lyfe" event designed to empower the community to build trusting relationships with health and wellness experts. Lyfe is spelled with a 'y' to highlight that this event is about asking questions like 'why' and finding answers.



National Donate Life Month

National Donate Life Month is a time to honor those who have given the gift of life through organ, eye and tissue donation; to celebrate those who have received a transplant and to encourage more people to say yes to donation.

Throughout April, our community worked together to share the message of donation with over 40 flag raising ceremonies, visits by 50+ ambassadors to DMVs and hospital tabling events. Over 800,000 people were reached through organic digital media.






